

The Ralls County Commission signed checks.


The Ralls County Commission were given the Unofficial Election Results by the County Clerk, Sandy Lanier.


The Ralls County Commission were presented a letter from RCS bank of the Security that had been pledged to the county court for file by the County Clerk, Sandy Lanier.

**The Ralls County Commission met with NECAC and signed a proclamation.**


**The Ralls County Commission signed a proclamation for Martha Northcutt who is turning 100 years old.**
