

THE RALLS COUNTY COMMISSION MEETING



The Ralls County Commission received the unofficial results of the August 2nd, 2016 election. A copy is attached.


The Ralls County Commission received the Circuit Court Disbursement report from Gina Jameson. Commission reviewed the report. A copy was filed with the County Clerks' office.


The Ralls County Commission read the minutes of the August 11th, 2016 meeting. Steve made a motion to approve the minutes and Wiley seconded. Motion passed.

The Ralls County Commission discussed general maintenance of roads in Ralls County with road supervisor, Danny Clark.


The Ralls County Commission signed checks and warrants as listed in the warrant registry.


THE RALLS COUNTY TAX LEVY HEARING

Wiley Hibbard made a motion to open the meeting and R.C. Harlow seconded.

Those present were Wiley Hibbard, R.C. Harlow, Danny Clark and Sandy Lanier.

Ralls County Commission held the public hearing for the County Revenue and Road and Bridge department tax levies. After discussion the commission set the County Revenue tax levy at .2762, and Road and Bridge at .2703. County Revenue is expected to bring in \$695,166 and Road and Bridge is expected to bring \$680,315. R.C. Harlow made the motion to accept the rates for County Revenue and Road and Bridge, Wiley Hibbard seconded. Motion passed.
