
**The Ralls County Commission signed payroll checks and one check for Springfield Electric.**

**WHEREAS**, manufacturing companies directly account for 260,700 Missouri jobs or 9.4% of the state's nonfarm payroll; and


**WHEREAS**, these jobs provide an annual compensation of \$67,407, which is significantly higher than the state's average wage; and


**WHEREAS**, manufacturing jobs enable Missouri families to realize the dreams of owning a home, educating children and enjoying a secure retirement; and


The Ralls County Commission voted on July 14<sup>th</sup>, 2016 to take over maintenance on Clinton Place, due to necessity and for emergency services.




