
Now on this day the Ralls County Commission met with Lynn Hodges. Fiber Optic will be available to 75 homes in Saverton West.

Now on this day the Ralls County Commission discussed road maintenance with Danny.


Now on this day the Ralls County Commission was given the official March 15th, 2016 election results by Sandy Lanier, County Clerk. A copy of results will be included with the minutes.


