Adopting the Ralls County Multi-Jurisdictional Local Hazard Mitigation Plan

Whereas, the County of Ralls recognizes the threat that natural hazards pose to people and property within our community; and

Whereas, undertaking hazard mitigation actions will reduce the potential for harm to people and property from future hazard occurrences; and

Whereas, the U.S. Congress passed the Disaster Mitigation Act of 2000 ("Disaster Mitigation Act") emphasizing the need for pre-disaster mitigation of potential hazards;

Whereas, the Disaster Mitigation Act made available hazard mitigation grants to state and local governments; and

Whereas, an adopted Local Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple FEMA pre- and post-disaster mitigation grant programs; and

Whereas, the County of Ralls fully participated in the hazard mitigation planning process to prepare this Multi-Jurisdictional Local Hazard Mitigation Plan; and

Whereas, the County of Ralls desires to comply with the requirements of the Disaster Mitigation Act and to augment its emergency planning efforts by formally adopting the Ralls County Multi-Jurisdictional Local Hazard Mitigation Plan; and

Whereas, adoption by the governing body for the County of Ralls demonstrates the jurisdictions' commitment to fulfilling the mitigation goals outlined in the Multi-Jurisdictional Local Hazard Mitigation Plan; and

Whereas, adoption of this legitimizes the plan and authorizes responsible agencies to carry out their responsibilities under the plan;


